Notice of Changing Non-Emergency Medical Transportation (NEMT) Provider

Dear Aetna Provider:

Aetna has contracted with LogistiCare Solutions, LLC (LogistiCare) to arrange and manage non-emergency medical transportation (NEMT) services to eligible Aetna Medicaid beneficiaries in regions 6, 7, and 11. LogistiCare will begin accepting requests for NEMT services on November 19, 2018 for services occurring on or after December 1, 2018.

All trips on or after December 1, 2018 must be pre-authorized by LogistiCare. They will accept requests for routine and standing orders (e.g., to regularly reoccurring medical services such as dialysis) Monday through Friday from 8 AM to 5 PM EST. These requests will require 24 hour (1 business day) advance notice.

Requests for urgent NEMT services (*i.e.*, non-life threatening) and Ride Assists are accepted 24/7/365. The Reservation number to request routine, standing order or urgent NEMT services is 866-799-4463.

The goal of this initiative is to provide safe, reliable, and cost efficient non-emergency medical transportation for our Aetna Medicaid members with improved access to healthcare services. To assist with meeting this goal, LogistiCare will be reaching out to Aetna providers to educate them on LogistiCare's process for arranging transportation and answer any questions about NEMT services. This is an opportunity to share important information that will facilitate a smooth transition from the current process to LogistiCare management.

LogistiCare is a HIPAA Business Associate of Aetna Better Health of Florida and is authorized to receive beneficiary private health information. Aetna requests that you assist in the implementation of this program and release requested information to LogistiCare.

Your cooperation and timely assistance will help to ensure a smooth implementation of the new NEMT brokerage program and help to ensure that your patients arrive to their scheduled appointments safely and on time.
