Dear Provider,

Effective **09/02/2019**, Aetna Better Health of Florida members that are currently under Region 11 will be transitioned to a network with CVS Caremark that continues to meet member access requirements but may offer fewer pharmacy providers.

As of **09/02/2019**, Walgreens and Publix will no longer be in our pharmacy network. The new pharmacy network will include CVS Pharmacy, Walmart, Winn-Dixie, and some independent pharmacies. Members will be able to utilize their current pharmacy until **11/04/2019**, 60 days after it has been removed from the network.

Members may also contact the Member Services department for assistance locating a pharmacy near them.

• If you electronically transmit or call in prescriptions for Aetna Better Health of Florida members, please be sure the pharmacy is <u>not</u> a Walgreens or Publix pharmacy after **09/02/2019**.
