Coordination of Care and Chronic Care Management

To our Hospital Provider Partners:

Aetna Better Health of Florida (ABHFL) would like to remind all providers including our children's hospitals that we offer and reimburse for Care Coordination and Care Management Services to members who are medically complex or have significant medical condition necessitating ongoing follow-up, treatment, and care coordination.

Care management is a collaborative process of assessment, planning, facilitation, care coordination, evaluation and advocacy for options and services to meet an individual's and family's comprehensive health needs. Each care manager works in conjunction with the member's primary or specialist physician as appropriate and coordinates their work activities with the Medical Director deemed appropriate.

Referrals to case management may be received from a variety of sources, such as:

- Primary Care Physician
- Specialist Physician
- Utilization Management team members
- Medical Director
- Member/family
- Internal departments

We welcome referrals from treating physicians to our case management program. You can submit a referral through the toll-free phone number on the member ID card or contact our Care Management team directly at 1-800-441-5501. Once we determine that a member is eligible for case management and the member or caregiver agrees to it, we make an individualized plan. We work with the member, the member's family, physician(s), and other health care professional(s) in formulating the plan of care.



Collaboration with our providers is critical to the success of any member plan of care. We encourage providers to document their care coordination services in their electronic health records and use the CPT codes below to submit for reimbursement as medically necessary.

Chronic Care Management CPT Codes

CPT	DESCRIPTION
99490	Minimum 20 cumulative minutes over a 30-day period of non-face- to-face time monitoring the care plan.
99439	Subsequent 20 minutes of care provided by clinical staff.
