As a reminder taxonomy is required on all claim submissions. Aetna Better Health understands that some of the clearing houses may not have turned on the taxonomy loop as part of the submission to the new Aetna Better Health of KY payor ID 128KY, in particular Gateway EDI. We have confirmation that Gateway did not fix this issue until on or around February 22<sup>nd</sup>. We are waiting on confirmation from other clearinghouses as well. On Monday March 7<sup>th</sup>, ChangeHealth (Emdeon) sent the following notice to all of clearing houses to remind them what needed to be done. In addition, Gateway has confirmed that they will be resending claims they have received prior to the update made in their system back to ChangeHealth (Emdeon). As a result, you will see on the next remit denials for any claims that were transmitted with no taxonomy, but please be assured that Gateway EDI has resubmitted these claims on your behalf.

If you do not use Gateway as your clearinghouse, please contact your clearinghouse to confirm that they have turned on the correct Loop segment below to transmit taxonomy. Once they have confirmed that the Loop is on, please ask them to resubmit your claims from January 25, 2016 and forward to Aetna Better Health. We are also working with ChangeHealth to try and identify other clearinghouses that may not have correctly set up our new Payor ID 128KY.
