## Provider Education - Billing

**Did you know** that a **Wellness Visit** and a **Sports Physical** can be performed on the **same day**?

When billing for a Sports Physical, use CPT code **99212** with diagnosis code **Z02.5**. If billing for **both** a Wellness Visit and a Sports Physical, **modifier 25** will need to be added to CPT **99212**. The **diagnosis pointer** for 99212 will need to indicate diagnosis code Z02.5.
