Effective 12/01/2025, provider requirements for receiving the SDoH incentive will update to reflect the following change.

For dates of service (DOS) on or after 12/01/2025, providers performing SDoH screenings must be licensed or provisionally licensed Behavioral Health (BH) providers. Unlicensed BH providers do not qualify for the SDoH Incentive.

Providers should utilize HCPCS code **G0136** (ADMINISTRATION OF A STANDARDIZED, EV) **in conjunction with the appropriate diagnosis (Z) code.**

G0136 billed independently will pay at the professional fee schedule rate on file with LDH. G0136 billed alongside one of the below Z code classes will pay the SDoH incentive rate:
