- CME application responses are due to the Plan by 5:00 PM EST on Wednesday, Dec 8, 2021. Please submit applications to CMEapplication@AETNA.com.
- You may apply for more than one catchment area, please use a separate email for each catchment area application.
- CME applicants should include any start-up costs in their budget. The Ohio Department of Medicaid (ODM) and Aetna Better Health of Ohio know that this program is about transitioning the way we do business and that organizations might need new to develop new resources to prepare for and manage the change. We anticipate and expect to see start-up costs included in the application budgets, which will help inform the grant making process. See the grant announcement here:
