### **Coming soon: Use Eviti Connect™ to Submit Requests for All Cancer Types and Imaging**

Dear Provider:

We wanted to share good news with you. Starting July 31, you'll be able to request, or bundle, response assessment imaging with your medical or radiation oncology treatment plans for all cancer types right on Eviti Connect™. You won't have to log in to another portal to request imaging. Even if you have separate teams to request treatment plans and associated imaging, everyone can submit their requests in Eviti Connect.

#### **Submit imaging now or use the new 'Add Imaging' button later**

Eviti Connect recently added an 'Add Imaging' button. Here's how it works: When you create a treatment plan, you can bundle response assessment imaging (like CT, MRI or PET) at the same time as your request. If imaging wasn't included when creating the original treatment plan, anyone in your office with access to Eviti can log in and add the imaging request later. Search for the patient's original treatment plan in the Saved Treatment Plan dashboard and click on the 'Add Imaging' button.

#### **Register for Eviti Connect**

Register for Eviti Connect at [www.eviti.com](http://www.eviti.com) if you're not already registered. If your office has employees who submit oncology imaging requests but don't already have access to Eviti, share this notice with them and ask them to register. By registering and entering your office's taxpayer identification numbers (TINs) and National Provider Identifiers (NPIs), imaging-only users can access the Saved Treatment Dashboard in Eviti and add imaging after a treatment plan has already been submitted.

#### **Sign up for on-site training**
