CPT Code Change for Prenatal Obstetrical Ultrasound

Effective **December 1, 2021**, Aetna Better Health of Virginia will change the way the following CPT codes will be processed for prenatal obstetrical ultrasound.

The codes on the following page will no longer require prior authorization but instead reimbursed according to the limits and requirements set forth in the attached policy.
