#### **Childhood Immunization Status (CIS)**



Children who turn 2 years of age in the measurement year and receive the following immunizations by their 2nd birthday:

- 4 DTaP, 4 PCV
- 3 IPV, 3 HIB, 3 Hep B
- 1 MMR, 1 VZV, 1 Hep A\*
- 2 or 3 Rotavirus (Rotarix vs Rotateq)
- 2 Influenza

\* MMR, VZV and Hep A must be given on or between the first & second birthday

# Immunizations for Adolescents (IMA)



Adolescents that turn 13 years of age in the measurement year and receive the following immunizations by their 13th birthday:

- 1 Meningococcal between 11th and 13th birthday
  - ⇒ Meningococcal Recombinant vaccines are <u>not</u> compliant (Serogroup B, MenB)
- 1 Tetanus, diphtheria toxoids and acellular pertussis (Tdap) on or between 10th and 13th birthday
  - $\Rightarrow$  Td is not compliant for HEDIS
- 2 (two-dose) or 3 (3-dose) HPV vaccines on or between the 9th and 13th birthday
  - ⇒ Required for females AND males
  - ⇒ 2-dose HPV vaccine series must be <u>at</u> least 146 days apart

### Coding Information:

- Tdap: 90715
- Meningococcal:90734
- HPV: 90649, 90650, 90651





Common reasons members still appear to have CIS and IMA 'Gaps in care' despite vaccinations given:

- Birth Hep B missing in claims and medical record
- An administered 2-dose Rotavirus not documented as a 2-dose (i.e. Glaxosmith Kline, Rotarix, Monovalent)
- CIS vaccines administered after the 2nd birthday
- Tdap, MCV and/or final dose of HPV given after age 13
- MCV given before age 11
- Vaccines given at other offices or health departments not billed or documented in the medical record.



#### **Use the WV Immunization Registry**

- · Remember to record all vaccines in WVSIIS
- Be sure name spelling, date of birth and vaccine entries are accurate and match the medical record
- Ensures a contiguous member vaccine record

### **Best Practices**

## Tips to improve CIS and IMA HEDIS® performance:

- Proper coding ensures compliance and decreases chart review
- ABHWV will pay for a well child visit outside of the 12-month cycle
- HEDIS requires more than school
   CIS—Rotavirus, Flu; IMA—HPV
- Schedule 2 year well child visits on or before the 2nd birthday.
- Schedule 13 year old well child visits on or before the 13th birthday
- Document the date of the first Hep B given at the hospital
- Differentiate between 2 or 3-dose Rotavirus (i.e. GlaxoSmithKline/ Merck, Rotarix/RotaTeq, Monovalent/Pentavalent,)
- Discuss HPV vaccination in terms of cancer prevention, The HPV vaccine is most effective before sexual activity begins.
- Recommend the HPV vaccine the same way and on the same day you recommend other vaccines.
- Obtain immunization records from other offices and HDs.
- Minimize missed opportunities use each visit to review vaccines and catch-up missing vaccines
- Contact members on your Gap in Care report to schedule vaccines.
