### HH – HCBS Amendment Rates Increase

Dear Provider,

This communication is to inform you that Aetna Better Health of Florida (ABHFL) has increased reimbursement rates for home-based care to cover the \$15 minimum wage increase.

Aetna Better Health of Florida (ABHFL) is currently sending amendments, retroactively effective to October 1, 2022, to all eligible providers.

#### What you need to know

- Your reimbursement for non-skilled services **will not** change if:
  - Your current contracted rate(s) for non-skilled services is a negotiated rate exceeding \$21.00 per hour (\$5.25 per 15-minute unit).
- Rate increase will be applied to previously paid claims for DOS on or after October 1, 2022.
